This appendix only concerns the registration and administration of domain names with the endings .SPA

Preliminary Remark:

Key-Sytems GmbH through 1API GmbH is a partner registrar of Asia Spa and Wellness Promotion Council Limited for the TLD .SPA

RSP and Key-Sytems GmbH agree that RSP can register, renew, transfer and administer domain names under .SPA for his customers through Key-Sytems GmbH.

The following paragraphs apply:

§ 1. Registration Requirements

All partner registrars and resellers of TLDs provided by Asia Spa and Wellness Promotion Council Limited domain names are committed to these terms and conditions. Each customer who registers a domain name has to accept the following terms and conditions. RSP is committed to bind his customers according to these regulations.

Community LandrushPeriod

During community landrush period, special considerations will be provided to allow the spa community to register names corresponding to their existing operations and brands. This will be introduced in addition to and consistent with the standard Sunrise, Trademark Clearing House and Trademark claims requirements according to the Applicant Guidebook and Specification 7 of the New gTLD Registry Agreement.

More specifically, to be eligible for community sunrise as a community member, the registrant must be able to provide information demonstrating that they have:

1. A valid operating license, where applicable;
2. A spa, beauty or wellness certification, where applicable;
3. A valid business registration;
4. A membership with any spa or wellness industry association;
5. A declaration that the domain will be used for the promotion of spas and wellness related products or services.

For community organizations, such as spa associations, to be eligible, the registrant must be able to provide information substantiating that they have:

1. A valid entity registration, or equivalent;
2. Proof that the organization accepts members from the spa and wellness community; and, 3. A declaration that the domain will be used for the promotion of the spa and wellness community

For non spa and wellness related coincidental communities registration type such as Town of Spa in Belgium as well as the Italian Chambers of Commerce who is responsible for “Società Per Azioni” (i.e. S.p.A.) registrations, the following information is required:

1. A valid entity business registration, or equivalent;
2. Director/Owner proof of identity
3. Address proof e.g. utility bill with address in Town of Spa or Italy

GA Registration Requirements

As .SPA is a community TLD, registration for .SPA TLD will be subjected to the registration policy clause

4 - Eligibility Criteria for Domain Names:

4.1 Community Mandatory Guideline To be eligible for .SPA domain, the registrant must be able to provide information demonstrating that they have any of the following:

An applicant in this category must be a commercial or trading company with a valid business registration certificate

A membership with any spa or wellness industry association;

A declaration that the domain will be used for the promotion of spas and wellness related products or services.

A valid operating license, where applicable;

A spa, beauty or wellness certification, where applicable;

4.2 Coincidental Community Guideline For non spa and wellness related coincidental communities

registration type such as Town of Spa in Belgium as well as the Italian Chambers of Commerce who is responsible for “Società Per Azioni” (i.e. S.p.A.) registrations, and any abbreviation which may form the word “SPA”, any of the following information is required:

An applicant in this category should provide a valid entity business registration, or equivalent;
Director/Owner proof of identity
required to furnish address proof e.g. utility bill with address

4.3 Individual Community Members must provide any of the following:

An applicant in this category must provide proof of identity which may include identification card copy, passport copy.

A declaration that the domain will be used for the promotion of spas and wellness related products or services.

A valid operating license, where applicable;

A spa, beauty or wellness certification, where applicable; Note that no proof of documentation is required during registration, but the registry implements post registration check and would request for supporting documents /proof of eligibility as and when deemed necessary.

§ 2. Domain-Name Dispute Resolution

§ 3. Transfer of Domain-Names Transfer Policy

In order to transfer a domain, the RSP of the customer must provide evidence of permission, either through the client directly or through an administrative contact. RSP will support Key-Sytems

GmbH with the registrar-transfer either to or from Key-Systems GmbH upon requirement, according to the Transfer-Policies of Asia Spa and Wellness Promotion Council Limited and ICANN.

§ 4. Duration

The registration or renewal of registration can take place for time periods between 1 and 10 years, in annual steps.

§ 5. Fees

RSP will ensure through its Registration Agreement that the registrants acknowledge and agree, that domain names may be variably priced under .SPA. This may also apply to transfers and renewals.

The prices of a standard registration and included services can be viewed directly through the WebInterface under the respective Top-Level-Domain. Premium prices will be provided upon request.

All costs will be charged in USD, meaning that when registering a Domain we will automatically exchange the respective fee into USD according to the daily exchange rate of the European Central Bank (ECB)

V.A.T. only applies to RSPs who have their corporate office in Germany or to RSPs within the European Union, who do not possess a valid V.A.T. ID. The V.A.T. Is not applicable to RSPs outside the European Union.

Individual pricing agreements, especially generalized pricing schedules that have been agreed upon prior to the availability of this TLD do not apply to the TLD(s) under this appendix. Only the prices listed in the account or individually agreed upon prices that explicitly refer to this/these TLD(s) apply

§ 6. Indemnification

RSP will ensure through its Registration Agreement that the registrants indemnify, defend and hold harmless Asia Spa and Wellness Promotion Council Limited and its subcontractors, and also the directors, officers, employees, affiliates and agents of each of them, from and against any and all claims, damages, liabilities, costs and expenses, including reasonable legal fees and expenses, arising out of or relating to the Registered Name. This indemnification obligation survives the termination or expiration of the registration agreement.
